OBJECTION TO REFEREE'S RECOMMENDED ORDER

You have 21 days to object to the order from the date the order was mailed to you. You must complete #1 through #3 before the objection period is over. If you do not complete #1 through #3, you lose your right to object and the referee's recommended order becomes a permanent order.

To object to a referee's recommended order you must do the following:

- 1. Contact Sandy Huttenga, Assistant Friend of the Court at 231-779-9494 ext. 2002 and order the transcript from your hearing. You will be required to pay for the transcripts before they are completed and before a hearing date will be given to you on your objection.**
2. You will be contacted with cost of the transcript. You must pay in cash, cashier's check or money order – **no personal checks will be taken.**
3. You will be required to bring your payment for transcripts directly to the Friend of the Court office or make arrangements with Sandy Huttenga to mail in your payment. Please complete and return the attached FOC68 form to Sandy Huttenga to complete the Notice of Hearing portion.
4. You and the other party in your case will receive a copy of the completed FOC68.
5. You will be contacted when the transcript is done.
6. The original transcript will be filed with the court for you. It is your responsibility to pick up your copy and your responsibility to serve the other party their copy of the transcript. We will NOT mail you the transcripts.
7. You must attend this hearing in person. You are not allowed to attend an objection to referee recommended hearing by telephone. If you do not appear at your hearing, your objection may be dismissed.
