## **Presentations and Reports**

1. Update of RAP

Dan Staub, Pescador Project Manager, presented the Board with an update of the landfill contamination area and the RAP. He informed the Board that three of the five wells have been shut down. The trash relocation was completed on March 11. The DEQ was involved and declared it complete. He then discussed the activity of the plum and the pace at which it's moving. Mr. Staub fielded questions from the Board. Some Board members felt that a joint meeting of the DEQ, Cedar Creek Board, and the County would be helpful to keep all interested parties informed on the landfill contamination.

#### **Public Comments**

Mary Hallett, Cedar Creek Township Treasurer, touched on the wells in the area of the contaminated water.

Mark Carlson, Manton, has property in the contaminated area, which now has a lien on the property. This lien is keeping him from getting a loan.

Fred Osborn, 103 Barbara Street, Cadillac, appreciates all the Board does to serve the public. As a fire fighter in the area for the past 24 years, he would like to see the 911 service stay in the area. He doesn't believe a 911 millage would pass if the Board takes the service out of the county. Mr. Osborn would like to see the Board work with the public service agencies.

Al Dowell, Manton, questioned the millage for the COA being for 6 years. He felt it may be too long. He would also like to see something in the language about nutrition on the ballot or part of the contract agreement.

Ormand Hook, 14622 190<sup>th</sup> Avenue, Big Rapids, came before the Board to announce that he was running for State Representative in our area. He provided the Board with his background and what he could offer if he were to be our representative.

Larry Rogers, Cedar Creed Supervisor, is tired of hearing about the RAP problems. He would like to have a joint meeting to get some of the problems and concerns taken care of.

Roll call: Motion passed seven to two with Commissioners Housler and Mitchell voting against the motion.

4. Grant between LARA and Wexford County for Medical Marijuana Operations and Oversight

MOTION by Comm Theobald, seconded by Comm Taylor to approve the grant between LARA and Wexford County for Medical Marijuana Operations and Oversight in the amount of \$11,712, for the period of January 1, 2016 through September 15, 2016, and authorize Lieutenant Denison to sign the Grant on behalf of the County, as presented.

Board members discussed why the Lieutenant was signing the Grant.

5. Resolution 16-13 Older Citizens Services Renewal Millage Proposal MOTION by Comm Taylor, seconded by Comm Theobald to approve Resolution 16-13 Older Citizens Services Renewal Millage Proposal, as presented.

A commissioner questioned the length of the millage requested and why was the vote in August and not November. Another commissioner felt it was important to have something included on the ballot language or in the contract agreement about nutritious meals, dining out, and home delivered meals. Many other agreements in other counties for Senior Centers have this as part of the language in the agreement or ballot language.

Roll call: Motion passed five to four with Comm MacCready, Housler, Howie, and Mitchell voting against the motion.

MOTION by Comm Howie, seconded by Comm Mitchell to eliminate the BOC Per Diem and allow BOC members to only submit mileage expense beginning June 1, 2016.

Roll call: Motion failed two to seven with Comm Housler, Hilty, Theobald, Taylor, Fuscone, Goodwill and MacCready voting against the motion.

Adm. Jordan provided Board members with a written report and touched on the TPOAM Union re-negotiations which have been set for 4/13/2016. Also the law suit against the jail project will be heard on 4/8/2016 at 2:00 p.m.

Comm Fuscone reported that they touched on the new audit for District Health and the IRS reporting on pension deficit. He questioned the effect it may have on the County. Also, the Octagon Committee met and received a report from Mark Pressell on the building. A couple of changes have been suggested and Mr. Pressell will make an adjustment to the report. The committee will get together in a week or so to review the changes.

Comm Howie believes that Cherry Grove has the best Fire Department. He touched on the preliminary 911 report.
