1. Tenurgy Utility Audit Presentation

Mike Herrington and Stan Snider appeared before the Board to explain how they could save the County money by reducing utility rates. With the Board's approval they would research back 18 months of utility bills. If a cost saving is found and the County agrees to participate in the savings, the savings would be split 50/50 with Tenurgy Utility. The agreement would be for 36 months. The Board would like to send this to committee for further review.

2. CWTA Presentation

Carrie Thompson, Director of CWTA, appeared before the Board to update them on some of the accomplishments that have been done over the past year. include: having a vision, financial turnaround, improved technology; etc. She explained how each one of those accomplishments may be put in place.

The CWTA millage will be expiring and they are anxious to have it placed on the ballot in 2016. Ms. Thompson's Board will be reviewing it and, because it is a County millage, the Board's counsel shall review it as well. She hopes to be back before this Board in March to seek the Board's approval of the millage.

Lisa Vogler, Owner Representative of the Jail Project, appeared before the Board to update them on the project. She believes that there will be enough competition for the County to receive competitive bids. There was some discussion at the Board level to look at hiring an agent in the middle of the jail project to make certain all is moving along properly. The suggested cost amount was around \$16,000 to \$17,000.

The Jail plans are still in the review process, but Ms. Vogler hopes that will be completed soon and the project can go out for bids.
