Meeting called to order at 5:30 p.m. by Chairman Leslie Housler.

Presentations and Reports

1. Injection Wells – American Waste

Vicki Garon, Engineer for American Waste, appeared before the Board to make a presentation on injection wells. American Waste/Wexford Water Technologies has made a proposal to the EPA and the DEQ to put injection wells at the landfill. They are requesting a Class 1 permit, which is for a deep well for non-hazardous materials which includes the disposal of leachate. Leachate tanks are in place now and from the tanks the leachate will go into the injection wells.

Ms. Garon then explained the process, materials and requirements they must follow to install the well. There are safety requirements put in place by the State including monitoring the well heads. They also have monthly reports they must file with the State as well an annual inspection. The proposed injection well will be located within the landfill boundary.

Public Comments

Michele Hoitenga, State Representative, explained that she does not generally get involved in local matters. She has been hearing from her constituents against the wells and felt it was important for her to step forward. She understands that economically it makes sense. However, due to the potential damage to the people of the county and the property values, she cannot support the wells.

Rita McNamara, Cedar Creek Township, appreciated the discussion made by this Board at the last meeting on the injection wells. She believes there is a great risk to health and Wexford County Board of Commissioners Regular Meeting * Wednesday, November 15, 2017 Page two (2)

property if the wells are installed. Cedar Creek Townships residents live with contamination every day. She concluded that when American Waste purchased the landfill they were aware of the leachate cost.

Fred McNabb, 10683 E. 16 Road, Manton, raised concerns about keeping contaminated water out of our lakes and streams. He felt contaminated water will raise to the surface.

Harry Yonkman, Boon Township, touched on his concerns about Petcoke.

Larry Paquette, Cedar Creek, does not support the injection wells being placed at the landfill. He believes they will fail and the problem will not surface until it is too late to take care of it.

John Fuscone, Cedar Creek Township, thanked the Board for passing the resolution tonight against the injection wells. He would like to see this county pass an ordinance against any injection wells in the county.

Board Comment

Comm Bengelink thanked Prosecutor Elmore for the information he provided the Board on the opioid litigation. Also, he understood the request made by American Waste, but the residents in his area (Selma and Cherry Grove) do not want the wells and he will not support them either.

Comm Theobald thanked the Board for working together on the injection wells and hearing from people from outside the area.

Comm Nichols thanked the Cedar Creek residents from coming forward. She also announced that the WEX will be open for walking on Tuesdays and Thursdays from 11:00 am to 1:00 pm.

Comm MacCready had brought the opioid litigation up at an earlier meeting. He would like the Board to consider passing an ordinance against injection wells. He also touched on feral cats and amending the Animal Control Ordinance to include them.

Chairman's Comments

Comm Housler understands the injection wells from a business standpoint. However, Commissioners are not elected to represent business. They are voted in to represent their constituents of Wexford County.
