Presentations and Reports

1. District Health Department #10 Annual Report

Linda VanGills, Health Officer for District Health #10, appeared before the Board to give the annual report. Board members were provided with a brochure which she went through touching on certain topics. She reminded Board members that their Medical Director, Dr. James Wilson, stepped down on July 1, 2013, and later passed away. They are now using a Medical Director from Mid Michigan Medical which is being shared among other agencies.

Ms. VanGills went on to state they have been successful in receiving their Public Health accreditation from the Michigan Health Accreditation Board. They are now in the process of trying to receive their National Public Health Accreditation. The Health Department is also working with a program "Promote Health" in Michigan for adults from 19-64 years of age.

The Dental Clinic has invested over \$80,000 to upgrade their facility. Currently, they serve approximately 2600 Medicaid clients.

Ms. VanGills also would like this board to pass a Resolution to restore State/Federal funding to their department in the amount of \$2 million.

Phil Potvin, State Rep, appeared before the Board to let them know that he would be running again for State Representative. Mr. Potvin is a resident of the Cadillac area. He believes that if we all work together as a team it will help all of us. The Governor does not understand that one size does not fit all. Those of us in the more rural areas have different needs than those in larger cities and townships. They are currently working on the 2014-2015 budget and hope to have it completed by June 2014.

Michael MacCready, Manton, believes this Board will have a problem getting the Wex millage passed.

Crystal Johnson, Cadillac, thanked the Board for hiring a person at the Animal Shelter. This added position will help to keep the facility open more hours. She then touched on the dollars charged for licenses and the need to split out the revenue received. This will provide for a more detailed accounting to indicate dollars earmarked to make certain State mandated requirements are funded.

Robert Miller, Cherry Grove, touched on the millage renewal for COA. He does not support putting any more money into the Wex. If the Jail is constructed, he would like to see all hiring from within Wexford County.

Dee Robinson, Marion, also thanked the Board for hiring a new shelter attendant. She would also like to see the dollars spent for Animal Control pensions recently return to the Animal Control fund.

Some Commissioners spoke up in favor of putting money into the Civic Center to update and repair some of the fixtures. A millage amount of .6 mills was suggested which would raise approximately \$530,000 and it would be only for one year. Others questioned if that was too much or not enough. After some discussion the consensus of the Board was to have both the Building and Recreation and the Finance Committee review this thoroughly. First it would go to Building and Recreation then to the Finance Committee.
