1. Approval of the Claims

<u>MOTION</u> by Comm Taylor, seconded by Comm Theobald to amend the travel/relocation reimbursement section of the employment contract to clarify the Board's intent to pay the \$10,000 as a travel/relocation bonus and pay the bills in the amount of \$881,412.09, as presented.

A commissioner questioned why payment of the bills at the Finance Committee came to halt and are now at Special Meeting to be approved. Maybe a policy should be put in place so this does not happen again.

Another Commissioner touched on the three bills that were not approved at the finance level. Out of the three bills, this commissioner understands the payment of the Title Commitment and Hiring Solution bill, and believes they have been clarified, but the early payment travel/relocation fee he was not comfortable with. He believes the fee should not be paid until the bills have been turned in for reimbursement. Another Commissioner did not believe that was the intention of the negotiating team; however, the agreement was put together the requirement to reimbursement travel expenses. Another Commissioner believed the \$10,000 relocation fee was a bonus. After counsel put the agreement together the requirement to not pay the travel expenses until the bills were

turned in was an oversight on the negotiating team's part. Another commissioner did not agree and did not feel that was the intention of the negotiating team.
