WEXFORD COUNTY BOARD OF COMMISSIONERS

Regular Meeting * Wednesday, April 4, 2018

Meeting called to order at 5:30 p.m. by Chairman Leslie Housler.

Roll call: Present – Commissioners Michael MacCready, Leslie Housler, Robert Hilty, Michael Bengelink, Michael Bush, Gary Taylor, Julie Theobald, Judy Nichols, and Bill Goodwill; Absent – None.

Pledge of Allegiance.

Additions/Deletions to the Agenda - None

Approval of the Agenda

<u>MOTION</u> by Comm Taylor, seconded by Comm Goodwill to approve the agenda, as presented.

Employee Recognition -

1. 20-year Service Award – Eric Garland, Sheriff's Department Mr. Garland was not present to accept his award. Chairman Housler read the Service Award to the audience.

Presentations and Reports

1. DHD #10 – Kevin Hughes, Health Officer, provided Board members with their Annual Report. He reviewed the report with the Board. One of the main issues is the water contamination near Camp Grayling. The detectible amounts are very small in most areas. However, this contamination issue may become statewide. The DEQ will now be testing more schools, and municipalities in our area.

Mr. Hughes explained that Michigan is seeing an increase in the Hepatis A outbreak. Currently, there are five in SE Michigan and it is moving north. Mecosta County has reported a case.

District Health Department #10 is seeing a turnover in staff. Over the past three years, they have had 180 employees leave for various reasons, including retirement. The positions are being filled and some new positions are being added to the Health Department.

Public Comments

Bruce Rendon appeared before the Board as a candidate for the 35th State Senate seat soon to be vacated by Senator Booher due to term limitations. He is looking forward to working with this Board.

Lt. Frank Keck, Post Commander of the Cadillac State Police Post, appeared before the Board in support of the requested Public Safety millage being requested at this meeting. He explained how the State has structured his department to cover five counties in the Northern Michigan area. It is difficult to cover this large of an area without the help and support of our local Wexford County Sheriff's Office. If a State car is called out to another county, they know Wexford County will be covered by the Sheriff's Office which is good for all.

Allen Sherburne, Captain of Mesick Rescue, explained some of the financial problems Mesick Rescue has been experiencing. He understands the County is still funding North Flight at \$25,000 per year. He explained some of the financial difficulties they have had over the past years. He asked if the County would support them with an appropriation of \$10,000.

Consent Agenda

1. Approval of the March 21, 2018, Regular Meeting Minutes

Resolution 18-07 Road Patrol Services Millage
 MOTION by Comm Nichols, seconded by Comm Taylor to approve Resolution 18-07 County Road Patrol Services Millage Proposal and Certifying Ballot Language, as presented.

It was pointed out that the requested millage rate for public services has not been increased over the past 30 years. The increase of the millage amount from .95 mills to 1.45 mills is needed. Population is increasing along with law enforcement needs. Sheriff Taylor would like to hire three more deputies, additional equipment, training, and bailiffs. Concern was raised by some Board members if the 1.45 mills would be approved by the public. It was pointed out that the Sheriff's Office does need more than the 1.45 mills requested, but if the millage is too large the public may vote it down. The 1.45 mills is something the Sheriff can live with. However, it was pointed out some jurisdictions may not approve the requested amount and what would the next step be for the County. Sheriff Taylor explained that if the millage does not pass he would be forced to lay off 8/10 deputies.

The title of the resolution and the ballot language was discussed. It was felt that it should be changed from Road Patrol Services to Public Safety millage to provide law enforcement services. Language within the ballot was also discussed and suggested changing the

The heading of the Resolution No. 18-07 changed: <u>COUNTY ROAD PATROL SERVICES-OF WEXFORD PUBLIC SAFETY MILLAGE FOR LAW MILLAGE ENFORCEMENT SERVICES PROPOSAL</u>

The body of the ballot language:

For the purpose of funding the <u>Public Safety</u> Law Enforcement Services fund to subsidize the continued operation of the County Sheriff's <u>Department Road Patrol</u> Office,......

If approved and levied in full, this Millage will raise an estimated additional-\$1,351,605 for County Sheriff's Office law enforcement services......

Sheriff Taylor would like the County Sheriff's Office to become more active with the schools, with resource officers, and deputies becoming more engaged with community. He also explained how the City and the County interact which is a win/win for both.

Comm Taylor called the question to end discussion. Roll call: Approved unanimously.

Comm Nichols withdrew her motion and Comm Taylor withdrew his second.

MOTION by Comm Theobald, seconded by Comm Taylor to correct the heading: Wexford County Public Safety Millage for Law Enforcement Services Proposal.

Roll call: Motion passed eight to one with Comm MacCready voting against the motion.

2. ORV Grant Agreement

MOTION by Comm Taylor, seconded by Comm Bengelink to approve the ORV Grant Agreement in the amount of \$18,000 for the period of October 1, 2017 through September 30, 2018, as presented.

Roll call: Motion approved unanimously.

He touched on the selling of the antenna at the Central Dispatch property. He asked if the County was prepared to make changes if the Public Safety Millage does not pass.

Chairman's Comments

Comm Housler would like to see the formula put in the newspaper for the amount of additional tax dollars the public would be asked to pay if the Public Safety millage does pass.
