WEXFORD COUNTY BOARD OF COMMISSIONERS

Regular Meeting * Wednesday, June 5, 2019

Meeting called to order at 5:30 p.m. by Chairman Gary Taylor.

Roll Call: Present- Commissioners Joseph Hurlburt, Mike Musta, Ben Townsend, Mike Bengelink, Michael Bush, Julie Theobald, Gary Taylor, Judy Nichols, and Brian Potter.

Pledge of Allegiance.

Additions/Deletions to the Agenda- None.

Approval of the Agenda

<u>MOTION</u> by Comm Theobald, seconded by Comm Potter to approve the agenda, as presented.

Employee Recognition-

1. Judge William Fagerman- 25 years

Chair Taylor read into the record the Employee Recognition for Judge Fagerman. Judge was not able to be present, but it will be delivered to him at a later date.

2. Kelly Dostal- 20 years

Chair Taylor presented Kelly Dostal with an Employee Recognition for 20 years of service with the County. She thanked the Board for the recognition.

Presentation and Reports -

Cadillac Wexford Library- Tracy Logan-Walker, Director of the Cadillac Library presented the Board with information regarding the 4 branches of the library: Cadillac, Mesick, Manton and Buckley. She explained all of the services that they are offering and where they see the most being utilized. Ms. Logan-Walker also explained how their funding works and their budget process.

Public Comments

Al Cooper, Wexford County Road Commission, came before the Board to inform them there will be a full road closure near Baxter Bridge for approximately 2 weeks. When they know the exact date, they will let everyone know.

Brent Schnell, Motorola Solutions, wanted to come before the Board to explain they are currently used by 75 out of the 83 counties. He explained all of the services that they currently offer and could offer to Wexford County.

Steven Peacock, Rehmann, presented the Board with the final report from the Independent Audit. He explained that the County received a Gold Standard report. There were 3 minor areas that they had suggestions for. He explained that they were very minor and did not affect any of the findings. Overall the audit was very efficient and clean.

2. 2019 Tax Rate Request, L-4029 Report

MOTION by Comm Theobald, seconded by Comm Bengelink to approve the 2019 Tax Rate Request, Report L-4029, and authorize the Board Chairman and County Clerk to sign the report on behalf of the County, as presented.

Joe Porterfield, Equalization Director, presented the Board with the L-4029 Report that shows that the County if properly applying any millages that we may see. This year there were not any millages expiring.

3. Resolution 19-11 2019 Summer Millage Rate for FY 2019 Budget

MOTION by Comm Nichols, seconded by Comm Potter to approve Resolution
19-11 2019 Summer Millage Rate for Fiscal Year 2019 Budget, as presented.

Joe Porterfield, Equalization Director, explained to the Board that this is something that happens every year. The Resolution is the notice to the public what the millage rate will be for the year.

4. Resolution 19-13 Fidelity Insurance Acceptance

5. Amendment to the Centralized Birth Certification System Agreement

MOTION by Comm Theobald, seconded by Comm Musta to approve the Revenue Agreement #20171718, Amendment #1 between the State of Michigan Department of Health and Human Services and Wexford County extending the expiration date to September 30, 2021 and increase the revenue by \$5,000, and authorizing the County Clerk to sign on behalf of the County, as presented.

Roll call: Motion approved unanimously.

6. Medical Examiner Investigator Fee

MOTION by Comm Musta, seconded by Comm Bengelink to approve increases for a Level One Investigator from \$75 to \$100, Level Two Investigator from \$95 to \$135 Natural and \$155 Non-Natural and a Certified Death Scene Investigator from \$115 to \$155 Natural and \$175 Non-Natural, as presented.

One Commissioner raised the question of what was changing to warrant the change in price. Another Commissioner explained that this increase would bring us equal to what other counties are paying.

Roll call: Motion approved 7-2 with Commissioners Hurlburt and Theobald voting against the Motion.

7. Grand Traverse Mobile Communications Agreement

MOTION by Comm Nichols, seconded by Comm Theobald to approve the agreement between Grand Traverse Mobile Communications and Wexford County for equipment, services and warranties as outlined in the proposal dated May 20, 2019 in an amount not to exceed \$349,338.00 and authorize the Board Chairman to sign on behalf of the County, as presented.
