Joy VanDrie, Executive Director of the Cadillac Area Visitors Bureau, provided the Board with a goodie bag of different maps, catalogs, and items from the surrounding areas of Cadillac. They do not only promote for the City of Cadillac, but for several areas surrounding. She explained several tourist attractions to the area and how they have made steps to improve their advertisements. They recently spent around \$50,000 on Google advertisement so that they are appearing more frequently in searches. The Bureau is now also printing visitor guides four times a year, as opposed to once a year like they used to do. Ms. VanDrie highlighted on the increase in visitor spending, which has increased by 85% from 2011-2017. In other surrounding areas, they have seen an increase, but not as substantial as the Cadillac area.
