SUBJECT: 2022 COVID-19 Leave

SUMMARY OF ITEM TO BE PRESENTED:

In March of 2020, the federal Families First Coronavirus Response Act (FFCRA) created 80 hours of paid leave for specified reasons related to COVID-19 for eligible employees. There were 34 Wexford County employees who used 1,431 hours of COVID leave in 2020. As part of the FFCRA, this leave terminated on December 31, 2020.

There was no similar 2021 COVID-19 leave mandated by the federal government. However, the Wexford County Board of Commissioners acknowledged that, given the prevalence of COVID-19, providing additional 2021 COVID leave would increase the stability of County operations and increase the safety of County employees and the general public. On February 3, 2021, the Board generously approved up to an additional 80 hours of COVID-related leave for eligible employees. There were 51 Wexford County employees who used 2,130 hours of COVID leave in 2021.

At a recent department head meeting, it was noted that COVID will be with us for some time to come, and that quarantine recommendations/requirements may change. Currently, the CDC recommends quarantining for those with a close contact if not vaccinated, or if vaccinated and showing symptoms.

On November 23, 2021 the HR/PS Committee approved a motion recommending that the full board approve eighty hours of 2022 COVID leave. Administration drafted Resolution 21-32, which was sent to the HR Director and the Clerk's Office for review. 21-32 is a revision of Resolution 21-06, which was recommended by legal counsel for approval of the 2021 COVID leave.

RESOLUTION NO. 21-32 TEMPORARY EMERGENCY COVID-19 LEAVE BENEFITS

- WHEREAS, in response to COVID-19 Pandemic, in March 2020 Congress approved and the President signed House Resolution 6201, the federal Families First Coronavirus Response Act of 2020 (FFCRA), which included the Emergency Paid Sick Leave Act (EPSLA); and
- WHEREAS, EPLSA benefits were offered to FFCRA eligible full time Wexford County employees and to part time Wexford County employees on a pro rata basis; and
- WHEREAS, the statutory EPLSA benefits expired on December 31, 2020; and
- WHEREAS, on February 3, 2021, in light of the fact that Congress had not reauthorized or mandatorily extended the EPSLA, the Wexford County Board of Commissioners recognized the need for emergency temporary COVID-19 leave and authorized up to eighty hours of Temporary Emergency COVID-19 leave to eligible full time County Employees and part time employees on a pro rata basis; and
- WHEREAS, the Board of Commissioners recognizes the need for additional emergency temporary COVID-19 leave benefit in 2022 due to the continuation of the COVID-19 pandemic; the fact that Congress has not reauthorized or mandatorily extended the 2020 EPSLA; and to foster and support prudent decisions by staff to treat or quarantine.
- NOW, THEREFORE, BE IT RESOLVED that the Wexford County Board of Commissioners hereby authorizes for 2022 the grant of up to eighty (80) hours of paid Temporary Emergency COVID-19 Leave to eligible full time County Employees and part time employees on a pro rata basis to be administered by the County pursuant to the eligibility and procedural requirements of the expired EPSLA leave. This additional County-provided leave is non-cumulative with leave granted or utilized in calendar year 2022; does not carry over from one year to the next; and, unused Temporary Emergency COVID-19 Leave is not subject to payout to employees or upon separation from employment.

BE IT FURTHER RESOLVED, that this authorization shall automatically terminate when the COVID-19 Pandemic is over, or December 31, 2022, upon Congress mandatorily extending/reauthorizing or providing a replacement to, in whole or in part, the expiring leave provisions of the EPSLA, or upon action by the Board of Commissioners terminating or amending this Resolution, whichever date is soonest.

If Congress does act to provide extended to replacement COVID leave benefits to eligible County employees, then the provision of leave for eligible County employees shall be exclusively governed by and subject to the requirements, terms, conditions, and procedures provided by applicable law and/or appropriate collective bargaining agreement leave provisions (for unit employees) or County leave policies (for non-unit employees).

SUBJECT: 2022 Non-Union Wages

SUMMARY OF ITEM TO BE PRESENTED:

The collective bargaining agreements approved by the Board of Commissioners in 2021 for the Technical, Professional, and Officeworkers Association of Michigan (TPOAM): General Courthouse Unit and TPOAM: Administrative and Supervisors Unit included wage increases of \$1.00/hour for all levels in 2022, a \$0.50/hour wage increase in 2023 and a \$0.50/hour wage increase in 2024. The contract for the Police Officers Association of Michigan (POAM) Non-312 Unit is currently under negotiation.

2020-2022 collective bargaining agreements (for Dispatch and POAM 312) included the same type of general wage increases, as did the Command Officers Association of Michigan 2021-2023 agreement.

In addition to union employees, the County also has many non-union employees and six elected officials. On December 5, 2018, following the ratification of collective bargaining agreement for the TPOAM units and the POAM Non-312 Unit, the Board of Commissioners unanimously approved a motion to implement the same base wage increases in 2019, 2020 and 2021 for Wexford County non-union and appointed employees.

RECOMMENDATION:

Finance Committee recommends to the full board for approval wage increases for full time and part time non-union employees and elected officials that mirror the 2022-2024 union contracts; exceptions would be judges, whose rate of pay is determined by the State of Michigan, and any employee who has an individual contractual agreement with the County.

Administrator's Report to the BOC

For the meeting of December 1, 2021

Completed Projects/Tasks

<u>FOIA Requests</u>: The Administration Office received 20 new Freedom of Information requests between November 1 and November 24.

Current Projects/Tasks

ARPA (American Rescue Plan Act): The Board has until December 31, 2024 to obligate the funds and until the end of 2026 to expend the funds. US Treasury's Final Rules have, at the time of this writing, not yet been released. The latest information is that the Final Rules will be available at some point in 2022, which is not high on the helpful scale.

<u>Coronavirus Emergency Supplemental Funding – Courts Round Two Funding</u>: An application, reviewed by the judges, was submitted ahead of the deadline. We have not yet received information on approval/denial of the application.

<u>Year End Tasks</u>: There are a number of things that happen toward the end of every fiscal year. These include submittals to the Michigan Dept. of Treasury (and uploading to the website) of the County's projected budget, performance dashboard, Citizen's Guide, and debt service report. These submittals are required in order to receive the FY 2022 CIP payments from the State. Another task is projecting departmental budgets of wages and benefits, accrued to December 31, to ensure that departmental budgets do not end in the negative. That task typically occupies nearly all of my time the last two weeks of December.

Additional Notes/Meetings

Michigan Association of Counties – Statewide County Administrator's Meeting: This meeting, held on November 18, was virtual. Much of the discussion circled around the pending opioid settlements and that there are many details regarding the settlements yet to be determined. What is known is that the settlement arrangement distributes the allocations over a period of 18 years, and that the annual distributions will not necessarily be the same every year. Expenditures will, of course, be required to meet eligibility requirements.

One additional point made by MAC staff was that there does not seem to be any real chance that the legislature will extend a virtual meeting option of the Open Meetings Act using a declaration of a state of emergency past the current sunset of December 31, 2021.

OSHA Emergency Temporary Standards (ETS)/MISOSHA Rules: Though the ETS has been stayed, resulting in a stay at the state level, the possibility exists that the stay will be lifted and that the rules will become effective.

Legal counsel has provided a template policy whose intent is to keep the County in compliance. Jami Bigger, HR Director, and I will complete the draft policy and have it ready to present to the Board of Commissioners for consideration if the need to have such a policy arises.

NMRE Response to

Senate Bills 597 & 598

As a society, we have seen firsthand the devastation the pandemic has had on the mental and behavioral health of our communities. It has also shined a light on the critical gaps in the current behavioral health system and, while Michigan mental health care is among the best in the nation, there is no doubt that more needs to be done.

Unfortunately, this crisis has also created opportunism by commercial insurers and others who claim they have the cure for "Michigan's broken behavioral health system". They blame the publicly governed behavioral health system for the lack of access to necessary services that should already be available by the same commercial insures and Michigan's privately managed Medicaid Health Plans (MHP).

In Senate Bills 597 and 598, introduced by Senator Mike Shirkey (R) and supported by Senator John Bizon, MD (R), the state would contract with private insurance companies, which are often owned outside of the state of Michigan, to provide a Medicaid health care benefit package that includes the full integration of physical and behavioral services, including those managed by local governmental entities. This type of privatization of behavioral health services leaves the counties, their Community Mental Health Service Programs (CMHSPs) and other safety net providers that work most closely with patients out of the governance and financing role. This plan would also place behavioral health services behind - or in competition with -- overall healthcare spending managed at the hands of large insurance companies – insurers that arguably have a monopoly and currently do not handle non-medical social supports that assist individuals living with substance abuse disorder, mental health diagnosis or intellectual/developmental disabilities.

Supporters of this bill also express concerns with an outdated Community Mental Health system struggling, or even failing, to meet mental health needs.

However, there is a side to this story that needs to be heard: The Northern Michigan Regional Entity, essentially owned and governed by the 21 counties in Northern Lower Michigan through their respective CMHSPs, has effectively serves nearly 19,000 individuals annually. Additionally, as the fiduciary responsible for the 21 counties, NMRE and its five member Community Mental Health Services Programs (CMHSPs), manage over \$200 million in Medicaid funding and federal block grant funding. These entities employ or contract approximately 3,000 individuals across the 21-county region. The NMRE's funding, unlike for profit or non-for-profit commercial insurance plans, goes directly to services or back to the state of Michigan tax payers.

Integrated physical and behavioral health care throughout Northern Lower Michigan exists because of Northern Michigan Regional Entity.

A leader in the state of Michigan for on the ground integrated behavioral and physical healthcare initiatives, NMRE has reinforced cost savings and increased benefits for the individuals we serve through partnering and adopting programs. Programs such as the Behavioral Health Homes Initiative, which began as a pilot in 2014. Building off that success and based on locally identified need, in 2018

the NMRE was also the first region in the state to start an Opioid Health Home to serve and combat the identified opioid crisis. Over the past several years, commercial insurers looked to us as a model and requested access to our network of resources we have provided for more than 50 years. This is especially important in rural areas of Michigan, as there is no competitive provider base; NMRE's network includes payors and providers to manage services for our local communities. These programs provide physical and behavioral health services coordination to all of the 19,000 people we serve, and the Opioid and Behavioral Health Homes alone have generated nearly \$1,000,000 in overall healthcare savings per year that goes back to the State of Michigan.

As best stated in a memo from the Michigan Association of Counties, the Michigan Sheriff Association, the Michigan Judges Association, and the American Civil Liberties Union of Michigan to Senate Majority Leader Shirkey & Members of the Senate Government Operations Committee opposing Senate Bills 597 and 598: "Thousands of families across the State of Michigan depend on the public mental health system for affordable, accessible care. The changes being suggested at the legislative level do very little to improve care and access for people with a mental illness or addiction. The proposal focuses solely on the administrative / managed care level, not the direct service level, and the suggested changes could in fact hurt individuals receiving the care they need at a time when so many across our state are struggling, vulnerable and in need of support".

"Our organizations want to express our support for Michigan's public mental health system and its strong local collaboration and problem-solving approach. Local law enforcement, judiciary, and prosecutors across Michigan have been in partnership with the Community Mental Health centers (CMHSPs and PIHPs) in their communities for years".

Throughout Northern Michigan, we have been steadfast in our efforts to support our neighbors battling mental and behavioral health crises. While we are grateful to see legislators taking note of this important issue, we are disheartened in the approach being taken to address the faults in the system.

"Where you live should not determine access to mental health care and mental health care, like all health care, must reflect how people live their lives," says Shirkey. On that, we can agree. But we also need to recognize that a one-size-fits-all approach does not work for Michigan. We must empower our local mental and behavioral health care leaders who have been invested in the people of their community for more than 50 years to continue doing the work they're equipped to do. Allow them the resources necessary to effectively do their jobs. Give them the ability to administer care holistically. Moving funding from public to private isn't the solution. What is? Backing those that have been doing the work all along, and giving them the ability to manage funding and care in a way that best benefits society.
