Administrator Porterfield explained that we did use \$500,000 of ARPA funds to help balance the budget, along with \$22,644 from fund balance. He doesn't want people to be too alarmed because he does have the HR Director budget for worst case scenario.

Administrator's Report-

Administrator Porterfield explained that the legislature has shut down for the year. They did pass the bill regarding solar panels that the Board passed a resolution opposing. It is now on the Governor's desk for signature. He did note that those wanting to utilize solar panels must still apply to the local units. There were also 3 juvenile justice bills passed, but one did not that would have helped the county out. The MIDC cannot represent juveniles.

Mr. Porte field noted that Operation Greenlight was a huge success. A photo of the courthouse was included in the MAC Newsletter. He thanked the Board for their continued support also.

Public Comments-

Michael Mix, Colfax Township Supervisor, wanted to address a county ordinance with the Board, ordinance 30-A. The biggest complaint he receives is that people cannot get electricity run to their property without a structure. The Colfax Township Board has no problem with people that want to camp on their own property. Section 7 of the ordinance specifies that their must be structure on the property. People want to come visit our area, and they want electricity. They can't get an address assigned either. He asked that the Board take a look at the ordinance and give back local control.

Comm Musta attended an AES meeting. Nikki Schultz is doing a great job and settling in.

Comm Townsend attended an airport meeting where they are working on completing their budget. He attended the Consumers Energy meeting in Mesick, where there is a lot of concern from people regarding the dam.

Comm Theoblad attended a DHHS meeting and emailed the information. She added that they are down 23 staff members, and recently had 430 hours of overtime between 15 people.
