AGENDA ITEMS

G.1. Maintenance Report

Mr. Adam Kerr, Maintenance Director, informed the Committee the old jail building has been sold. Because of that, Mr. Kerr has lost some storage space. He is on the waiting list for another storage unit. Veterans Services is looking into possibly getting their own storage unit to store ramps and other items.

Mr. Kerr also informed the Committee of the following:

- The grout has failed in front of the dish station at the new jail, so he will be replacing that.
- MiWorks is still in the process of moving out of the Lake St. building.
- Mr. Porterfield and himself will be meeting with Schepers Concrete to revisit the sidewalks and what can be done about the deteriorating brick at the courthouse.

G.2. Civic Center Report

Mr. Mike Figliomeni, Boon Sports Management, informed the Committee the ice was removed from the Wex last week. They wrapped up their season with a successful three-on-three tournament.

Mr. Figliomeni also stated BSM is still struggling with the loss of their management team. Efforts to replace the positions are ongoing. With the positions vacant, Board members have stepped in to help.

G.3. Vending Machine Discussion

Mr. Porterfield, County Administrator, informed the Committee he had reached out Lange Vending, but has not yet heard back. He also reached out to another local vendor who called him back during the meeting. Mr. Porterfield will follow up with that vendor and continue to reach out to anyone that he can find.

The Committee discussed the need for snack vending and pop machines for both employees and members of the public to utilize. Commissioner Theobald asked that this agenda item occasionally appear on future agendas until the County can find vending.

Mr. Porterfield informed the Committee that:

- The closing on the old jail took place on Wednesday.
- The new transformer has been set up at the Fairgrounds. He is looking into putting concrete barriers around the transformer.
- He has reached out to Vets Serving Vets to inquire about finishing the removal of the concrete at the Fairgrounds.
- He is looking for funding to purchase a full body scanner for the jail in an effort to ensure contraband does not enter the jail.
- He will be reaching out to Schepers Concrete for a meeting with them and Mr. Kerr to see what can be done about the deterioration around the front entrance of the Courthouse.
